### Speaking the Language: The Right to Interpretation & Translation Services for Children and Adolescents with Mental Health Needs in Maryland (November 2022)

Speaking the Language, a report co-authored by Centro SOL and the PJC, describes the experiences of children and adolescents who were denied recommended mental health care due to their primary and preferred language as well as families who struggle to coordinate care for their young children when their request for interpretation and translation is denied. The report also highlights challenges to providing interpretation and translation from the perspective of mental health providers. Centro SOL and the Public Justice Center offer five recommendations to mental health providers and policymakers to close the gap in communication between patients and their providers to ensure the provision of timely mental health care with necessary language services.
